Sir,

With reference to the subject cited above, I am directed to convey the approval of the Ministry of Ayush to reduce the minimum qualifying percentile criteria of EWS- PwD category by 5 percentile i.e. from the 45th to 40th percentile in EWS-PwD category under Ayurveda, Siddha, Unani and Homoeopathy (ASU&H) streams as per directions of the Hon'ble High Court of Judicature, Allahabad and as per the proviso to Regulation 8(iii) of the IMCC (Post Graduate-Ayurveda/Siddha/Unai/Homoeopathy) Amendment Regulations 2018.

- 2. In view of the above, it is requested that the Joint Commission (NCISM&NCH) ask the National Testing Agency (NTA) to share the additional AIAPGET qualified candidates data after the revised percentile criteria for EWS-PwD candidates (i.e. 40^{th} percentile) under ASU &H streams and share the same to the Central/State/UT counseling Authorities. It is further requested to upload a public notice regarding the matter on the website (NCISM/NCH).
