Sub: - Provision of Adjunct registration to registered AYUSH practitioners for practicing in other States/U.T.-reg.

Madam / Sir,

National Commission for Homoeopathy, Board of Ethics and Registration for Homoeopathy has noted the issue of practitioners registered in one State/UT Board/Council and wants to practice/seek job in other State/UT.

As per section 59 (2) of NCH Act 2020, "The educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder."

Further as per provisions of Section 26 (2) of HCC Act 1973 "Subject to the provisions of sub-section (3) of section 15, any person whose name is for the time being borne on Part II of the Central Register of Homoeopathy, may practice Homoeopathy in any State, other than the State where he is enrolled on the State Register of Homoeopathy with the previous approval of the Government the State where he intends to practice."

On the directions of Ministry of AYUSH, The erstwhile Central Council of Homoeopathy had issued a circular in this regard vide its letter No. 13-04/2020-CCH(Misc)/1382 dated June 14, 2021 with the approval of BOG. A copy of letter dated 14.06.2021 is enclosed for ready reference.

There is no requirement of cancellation of Registration from other States as per provisions in the Act. In view of the above, it is requested to ensure that the State Board/Council in your State/UT comply with the letter of erstwhile Central Council of Homoeopathy dated 14.06.2021; facilitate; and dispense off such requests made by Homoeopathic Practitioners in timely manner.
