F.No. 3-34/2023/NCH/HEB/C.C/Pt.I —In exercise of the powers conferred by sub—section (1) and clauses (h), (i), (q), (s) and (t) of sub-section (2) of section 55 of the National Commission for Homoeopathy Act, 2020 (15 of 2020) the Commission hereby makes the following amendment in National Commission for Homoeopathy (Homoeopathy Graduate Homoeopathic Medicine and Surgery (B.H.M.S). Regulations- 2022

- 1. Short title and commencement. (1) these regulations may be called National Commission for Homoeopathy (Homoeopathy Graduate Degree Course Bachelor of Homoeopathic Medicine and Surgery (B.H.M.S). Amendment Regulations-2023.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. in page 49, after sub-regulation (2) of regulation 1 following shall be inserted after words $^{\prime\prime}^2N.B$ " as under:-

²N.B "The amendment notified in these regulations on (date of publication of amendment) shall apply from students admitted in BHMS Homocopathy Graduate Degree Course from academic session (2022-23) onwards.

- 3. in page 49, sub clause (a) of regulation 4 following small be substituted with:
 - (a) the candidate shall have passed 10 +2 (or equivalent) with subjects of Physics, Chemistry Biology or Biotechnology.
- 4. in page 51, after sub clause (12) of regulation 4, sub clause (13) shall be inserted as under:
 - (13) 'the Central or State Government or Union Territory counselling authority shall submit complete data of allotted students to the National Commission for Homoeopathy in the format, mode of submission and the time line specified by National Commission for Homoeopathy from time to time for verification;
- 5. in page 51, Table 1, row (4) of column (2), the word '(Final)' after Fourth shall be omitted
- 6. in page 55, following point shall be inserted in section 7 at serial no. (3) as under:
 - (a) CBDC at graduate level the Homoeopathy Education Board shall publish the competency based dynamic curriculum and the cutcome objectives of the same from time to time on the NCH website. The curriculum standards are subject to modification from time to time with the changing healthcare scenario.
- 7. in page 58, sub clause (15) of regulation 9, word 'Explanation' shall be inserted as below:

Explanation:- Theory and practical examinations are two components of same subject. If student fails in any one of the component or both it shall be treated as failed in the subject and in such case, the student shall appear for both theory and practical examinations.

8. in page 59, sub clause (b) of clause (17) of regulation 9 shall be omitted

- 9. in page 59, sub clause (c) of clause (17) of regulation 9 shall be read as (b), and (d) shall be read as (c)
- 10. in page 59, line 36, sub clause (a) of clause 24 of regulation 9, read word 'final' as 'all' before professional
- 11. in page 62, line 3, sub clause (i) of clause (b) of regulation 11, omit word 'final' before University
- 12. in page 62, line 7, sub clause (ii) of clause (b) of regulation 11, omit word 'final' before University
- 13. in page 62, Table-8, row (4) of column (2), the word '(Final)' after Fourth shall be omitted
- 14. in page 62, Table- 8, row (4) of column (3) (c), read (FUE) as (UE)
- 15. in page 62, Table- 8, row (1) of column (3)(c), read (FUE) as (UE)
- 16. in page 62, Table- 8, row (2) of column (3)(c), read (FUE) as (UE)
- 17. in page 62, Table-8, row (3) of column (3)(c), read (FUE) as (UE)
- 18. in page 62, below Table- 8, line 9, the word 'Final' before University shall be omitted
- 19. in page 62, below Table- 8, line 9, read (FUE) as (UE)
- 20. in page 63, line 2, sub clause (a) of clause (2) of regulation 11, the word 'Final' before University shall be omitted
- 21. in page 63, line 3, sub clause (a) of clause (2) of regulation 11, following shall be inserted after word assessment:

'which shall include the complete syllabus for that respective professional year'.

- 22. in page 67, line 45, sub clause (c) of clause (1) of regulation 14, the word '(Final)' after Fourth shall be omitted
- 23. in page 67, sub clause (c) of clause (1) of regulation 14, the word 'Provisional Degree certificate from respective University and' shall be omitted
- 24. in page 73, line 46, clause (1) of regulation 18, the word '(Final)' after Fourth shall be omitted
- 25. in page 79, Note 2, after Appendix "B", (sub regulation (5) of regulation 4), the following shall be substituted with:-
 - "and in case of non-availability of eligible candidates in any category the unfilled seats shall be converted into the general category of All India Quota seats or State Quota seats as the case may be"
