Sub: Steps to be taken for curbing the menace of ragging in Homoeopathic Medical Colleges as per the guidelines given by University Grant Commission-reg.

Madam/Sir,

With reference to the subject cited above, Principals of all Homoeopathic Medical Colleges are hereby directed to setup Anti-Ragging mechanism by way of following guidelines and submit the below mentioned Action Taken report within 6 months. Following action are to be taken at the earliest.

- 1. Conduct an Awareness class and campaign for the senior students.
- 2. Conduct awareness class on Anti-ragging measures with the help of video obtained from website of UGC.
- 3. Submit students' details (address, phone number, hostel etc.) to the nearest Police Station.
- 4. Update website with complete address of Nodal Officers related anti-ragging committee with contact details.
- 5. Display anti-ragging posters where ever necessary.
- 6. Conduct surprise inspection in Hostel, Canteen, and Toilets etc.
- 7. Install CCTV Cameras in the college campus.
- 8. The institution shall identify, properly illuminate and keep a close watch on all locations known to be vulnerable to occurrences of ragging incidents.
- 9. The contact numbers, details of control room, helpline and the personnel related to antiragging activities shall be prominently displayed, provided and easily available to freshers and all concerned so that immediate contact can be established whenever necessary.

Students in distress owing to ragging related incidents can access the National Anti-Ragging Helpline 1800-180-5522 (24x7 Toll Free). Any other information regarding ragging may please visit the UGC website i.e. www.ugc.ac.in.

- Step 1: A student will submit his/her details on the same web sites (www.amanmovement.org) as before; read and confirm that he/she and his/her parents/Guardians have read and understood the regulations on curbing the menace of ragging. He/She will confirm & agree that he/she will not engage in ragging in any form. (Step 1 is the same like before).
- Step 2: The student will receive an Email with his/her registration number and a web link. The student will forward the link to the Email of the Nodal officer in his/her university/college. (Please note that the student will not receive pdf affidavits and he/she is not required to print & sign it as used to be the case earlier).
- Step:3 The Nodal Officer in the university/college can click on the link of any forwarded emails that he/she will receive from any student of his/her college to get the list of those students who have submitted Anti Ragging Affidavits/Undertakings in his/her college. The list will be updated every 24 hours.

The College may report any sort of non-cooperation from the part of the senior students or act of ragging shall be communicated to the National Commission for Homoeopathy, and the Parents/Guardian of the newly enrolled students.

The College may arrange an orientation programme for the juniors as well as the seniors students by consulate/counsellors/legal authorities for establishing emotional securities amongst the new batch of students all Principals/Directors are directed to strictly adhere to the above directions/guidelines and report of the Anti-Ragging Committee detailing all un toward incidences within 03 months of the classes have started shall be submitted to NCH.
