Sub: Ministry’s Decision on Non-NEET admissions made by the colleges of Maharashtra in UG (BHMS) for the A.Y 2019-20 with reference to the order dated 16.05.2023 in the Special Leave Appeal (C) 1525/2023 passed by the Hon’ble Apex Court- reg.

Sir/Madam,

I am directed to refer to the letter dated 19.10.2023 of the Commissioner, Medical Education and Ayush, Govt. of Maharashtra (**copy enclosed**), and the Hon’ble Supreme Court order dated 20.02.2020 in the Civil Appeal No. 603/2020 and Hon’ble Supreme Court order dated 16.05.2023 in Special Leave to Appeal (C) No 1525/2023 (**copy enclosed**) and to say that as per the expert opinion of the National Commission for Homoeopathy and considering the future and career of the students, it has been decided to allow the 155 non-NEET candidates to continue their studies whose admission have been made by 13 Homoeopathic colleges of Maharashtra in the BHMS course for the academic year 2019-20, as per the conditions mentioned below:

- i. Penalty of Rs. 25.00 lakhs along with reduction of seats corresponding to the number of students admitted in an irregular manner for the academic year 2024-25 in these colleges should be imposed upon such colleges who have admitted students below NEET qualifying criteria, which shall be deposited to National Commission for Homoeopathy.
- ii. Penalty of Rs. 50 Lakhs along with reduction of seats corresponding to the number of students admitted in an irregular manner for the academic year 2024-25 in these colleges should be imposed upon such colleges who have

- admitted students with marks below 50% in higher secondary examination (i.e.12th Class), which shall be deposited to National Commission for Homoeopathy.
- iii. The State Government should ensure that no amount of penalty shall be charged in any form from any of the students of the college and penalty fee shall be borne by the college management.
 - iv. All these colleges must refund the full fees as received from such students since the date of admission.
 - v. Further, based on the responsibility undertaken by the State Government through the NOC issued at the time of establishment of the College, the State authority should transfer such irregularly admitted students to other recognized Homoeopathic Colleges under the same University affiliation subject to the availability of infrastructure and availability of seats by the State Government with the concurrence of the University.
2. This is issued with the approval of the Competent Authority.
 3. This shall not be treated as a precedent.
