All India Quota (AIQ) Seats under UG (BAMS/BSMS/BUMS/BHMS/B.Pharm-ITRA) Courses (ASU&H) for A.Y. 2025-26.

- All the eligible candidates who qualified for NEET (UG)-2025-26 examinations and aspiring for admission in Undergraduate (BAMS/BSMS/BUMS/BHMS/B.Pharm-ITRA/ASU&H) courses, respectively, are hereby informed that the AACCC UG Counseling 2025-26 for allotment of AIQ - UG seats of ASU&H-UG courses will be held 22nd August, 2025 as per schedule which uploaded on AACCC website (<https://aaccc.gov.in>)
- AACCC, National Commission for Indian System of Medicine (NCISM) shall conduct counseling for admission in AIQ seats of ASU&H-UG courses under Government/Government Aided College/Institute, National Institutes, Central Universities and Deemed Universities (established under Central Act).
- The counseling for admission to AIQ seats of UG courses in Private Institutes of Ayurveda, Siddha, Unani & Homoeopathy shall be conducted by the respective counseling authority of the State/UT Government.
- For participation in AACCC UG Counseling 2025-26, the candidates are required to register themselves at the official website of AACCC (<https://aaccc.gov.in>)
- Kindly note that 'Non-Refundable registration fees' and 'Refundable Security Deposit' have to be paid by the candidates at the time of registration as per their category and selection of counseling on the portal
- For allotment of AIQ-UG seats under ASU&H stream under Government/Government aided Institutes/Colleges, National Institutes, Central Universities, Deemed Universities, AACCC, National Commission for Indian System of Medicine (NCISM) will conduct four rounds of counseling through online mode: i.e. **Round 1, Round 2, Round 3 and Stray Vacancy Round (Phase I & Phase II allotment)**

Round	Conditions*
I	Free exn
II	Exit with forfeiture till 03 days before commencement of R-3. If withdrawn beyond this period till R-3 result, shall become ineligible for AACCC counseling
III	After the R-3 result publication, one must join the allotted/upgraded seat or else counseling fees shall be forfeited & will become ineligible for further AACCC/State/UT counseling
Stray Vacancy Round (SVR)	Phase-I: - Fresh registration and choice filling available during SVR-I. After the SVR-I result publication, one must join the allotted seat or else counseling fees shall be forfeited & will become ineligible for further AACCC/State/UT counseling
	Phase-II: - No registration and choice filling in SVR-II. Choices locked by candidates in SVR-I shall be exercised as per merit and preference for phase II allotment on non-reported seats of SVR-I. After the SVR-II result publication, one must join the allotted seat or else counseling fees shall be forfeited & will become ineligible for further AACCC/State/UT counseling
	Non-registered eligible candidates willing to participate in SVR MUST register themselves during SVR-I.
