Sub : Advisory to submit Affidavit/Undertaking by candidate and college authority participating conditionally in Ayush Admission Counseling - UG/PG course in Homoeopathy for the A.Y. 2025-26-reg.

Sir/ Madam,

With reference to the above cited subject, it is to inform that colleges permitted for admission by the Competent Authority are only allowed to participate in the Ayush Admission Counseling.

It has been noticed that at occasions certain colleges are allowed to participate in the counseling based on interim order passed by Hon'ble Court. Further, certain colleges intentionally by misinterpretation admit students without counseling authority which is illegal. In such situation, it may happen that University the affiliating/exam conducting body does not allow such students to appear in the examination. At times, it has also been noticed that the final order by the Hon'ble Court is without imparting any relief and this creates a drastic situation for the students to which he/she has not anticipated affecting their future adversely.

In view of the above facts, the Counseling Authorities are directed as under:

- i. The counseling authorities and the participating homoeopathy institutions/colleges shall essentially display the permission status of the college for admission in A.Y 2025-26 issued by Competent Authority and the copy of the interim order, if any, in this regard along with the updates issued from time to time, on the official/college website.
- ii. To verify the final University affiliation status of the Homoeopathic Colleges for the A.Y. 2025-26.
- iii. To ensure the candidates are well aware of the permission status of the allotted college particularly in cases of conditional permission granted through interim order by Hon'ble Court. –

- v. The admission done on the basis of interim order by Hon'ble Court shall be provisional and subject to the final order in the matter.
- vi. The Principal of the college shall submit Affidavit-cum-Undertaking to the Ayush Counseling Authority in cases where admissions are based on conditional permission through interim order by the Hon'ble Court. **(Annexure-I)**
- vii. The student shall submit Affidavit-cum-Undertaking to the admitting college in cases where admission is done on conditional permission through interim order by the Hon'ble Court. **(Annexure-II)**

All State/UT Ayush Counselling Authorities are instructed for strict necessary compliance in the interest of participating students for admission and for the smooth conduction of counselling.
