**Sub - Clarification in respect of eligibility for Paper Setter, Theory Examiner, and Viva/Practical Examiner for the subject "Essentials of Modern Pharmacology" in IV BHMS (CBDC) – reg**

Homoeopathy Education Board is in receipt of several representation from various colleges for seeking clarification regarding the eligibility of faculty for appointment as Paper Setter, Theory Examiner and Viva/Practical Examiner for the subject "Essentials of Modern Pharmacology" in IV BHMS (CBDC).

In light of above, it is to state that **PART III—SEC.4 page 103, E (3)(d)** of The National Commission For Homoeopathy (Minimum Essential Standards for Homoeopathic Colleges and Attached Hospitals), Regulations - 2024. States that:

*A separate visiting faculty with a minimum designation of Assistant professor having qualifications as specified in the Third Schedule shall be engaged for teaching essentials of modern pharmacology.*
