F. No. 3-35/2024/NCH/HEB/MSR.C.Pt. III– In exercise of the powers conferred by sub-section (1) and clauses (s) and (t) of sub-section (2) of section 55 read with clauses (d) and (e) of sub-section (1) of section 26 of the National Commission for Homoeopathy Act, 2020 (15 of 2020) the National Commission for Homoeopathy hereby makes the following amendment in the National Commission For Homoeopathy (Minimum Essential Standards For Homoeopathic Colleges And Attached Hospitals), Regulations - 2024.

1. Short title and commencement. – (1) These regulations may be called the National Commission for Homoeopathy (Minimum Essential Standards for Homoeopathic Colleges and Attached Hospitals) Amendment Regulations, 2024.
(2) They shall come into force on the date of their publication in the Official Gazette.
2. Sub clause (a) of clause (3) of A-General of First Schedule to be read as:
Biometric attendance. - (a) All Medical Colleges/Institution shall connect with centralized Aadhaar Enabled Biometric Attendance System for marking attendance of the required staff (faculty, residents, interns and supporting staff) and National Commission for Homoeopathy will access attendance data online from centralized Aadhaar Enabled Biometric Attendance System.
3. Point (i) of sub-clause (c) of clause (11) of A. 'General' of the Second Schedule to be read as Pharmacist: 02 instead of Pharmacist: 01.
4. After first paragraph of sub-point (A) of point (i) of sub clause (A) of clause (3) of B of the Third Schedule, following to be added:
or teachers holding post-graduate degree in psychiatry and five years of teaching experience in the Department of Organon of Medicine shall also be considered for appointment in the Department of Organon of Medicine; or teachers holding post-graduate degree in Pediatrics or Psychiatry or Dermatology and five years of teaching experience in the Department of Practice of Medicine shall also be considered for appointment in the Department of Practice of Medicine;
5. Sub-point (A) of point (a) of clause (4) of B of the Third Schedule to be read as:
Recognised post-graduate degree in Homoeopathy in the subject concerned; or candidates holding recognised post-graduate degree in Psychiatry shall also be considered for appointment in the Department of Organon of Medicine; or candidates holding recognised post-graduate degree in Pediatrics or Dermatology or Psychiatry shall also be considered for appointment in the department of Practice of Medicine; and
