NATIONAL COMMISSION FOR HOMOEOPATHY (DRAFT REGULATION)

New Delhi, The December, 2022

In exercise of the powers conferred by sub-section 2 of Section 55 of the National Commission for Homoeopathy Act, 2020 (15 of 2020) and in supersession of the Homoeopathy Central Council (Inspectors and Visitors) Regulations, 1982, except as respects things done or omitted to be done before such supersession, the National Commission for Homoeopathy hereby makes the following regulations namely: -

- 1) **Short title and commencement** (1) These regulations may be called as "The National Commission for Homoeopathy (Assessment and Rating of Medical Institutions Regulations, 2022".
- 2) They shall come into force on the date of their publication in the official gazette of Govt of India
- 3. **Definitions**—in these regulations, unless the context otherwise requires
 - a) "Act' 'means, the National Commission for Homoeopathy Act, 2020 (15 of 2020);
 - b) "Commission" means the National Commission for Homoeopathy constituted under section 3 of the Act;
 - c) "Attached hospital" means a teaching homoeopathic collegiate hospital attached to the medical institution;
 - d) 'Course' means the courses of study in Homoeopathy namely:
 - B.H.M.S.- (Bachelor of Homoeopathic Medicine and Surgery);
 - M.D. (Hom) (Doctor of Medicine) (Homoeopathy) in various specialty subjects;
 - Any other course as may be recognized by the Homoeopathy Education Board:
 - e) "Form" means a Form annexed to these regulations;
 - f) "Scheme" means an organized plan of furnishing information about the Medical Institution for achieving permission and rating;

- g) 'Minimum essential standards' means standards laid down by Homoeopathy Education Board for conducting course(s), examinations and includes norms for infrastructure, faculty and quality of education and research in medical institutions
- h) 'Inspector' means a team of experts appointed or through the hired and authorized third party agency by the Medical Assessment and Rating Board for Homoeopathy for carrying out inspection of medical institutions for assessment & rating and maintenance of minimum essential standards as specified
- i) The words and expression used herein and not defined, but defined in the Act shall have the same meanings as respectively assigned to them in the Act.

4. Procedure of assessment and rating of existing Medical Institutions.

- (a) Each existing medical institution will submit information in structured format by offline/online mode with relevant annexures on annual basis along with the specified fees to the Medical Assessment and Rating Board of Homoeopathy for assessment, rating and maintenance of minimum essential standards., before the last date as may be specified by the Board.
- (b) Applications received on or before the specified last date of submission along with the required fees shall only be accepted.
- (c) The medical institution shall submit continuance of affiliation certificate from the University for the preceding year along with application.
- (d) All the eligible medical institution shall seek rating by assessment after a period of 5 years of opening and every year thereafter, subject to maintenance of minimum essential standards as specified.
- (e) The certified copies of English/Hindi translation of all the annexures, which are not in English or Hindi language, shall be annexed with the Application form.
 - The Medical Assessment and Rating Board for Homoeopathy shall verify by conducting inspection through offline/online/ hybrid mode for the fulfillment of the medical institutions in terms of compliance of maintaining minimum essential standards followed by rating of such institutions.
- 5. Fee to be submitted along with application: The application submitted under regulations shall be accompanied by the following fee by way of a demand draft or

online payment, payable to the 'National Commission for Homoeopathy, New Delhi'.

6. Manner of appointment of inspectors or independent rating agencies.

- (a) The President of Medical Assessment and Rating Board for Homoeopathy shall appoint such number of inspectors to inspect the medical institution for assessment & rating and maintenance of minimum essential standards as specified,
- (b) No person shall be appointed as an inspector unless he/she possesses the following qualification namely:
 - (i) A recognized post graduate medical qualification in Homoeopathy included in the Degree Recognition List maintained by the Homoeopathy Education Board of the Commission;
 - (ii) And having at least 5 years professional experience in a State or Central government or autonomous institution.
- (c) Medical Assessment and Rating Board for Homoeopathy may also hire services of public sector agency, having experience of similar work of assessment or rating of medical or non-medical institutions, as independent assessment and rating agency by calling Expression of interest on mutually agreed terms and conditions after approval of the Commission.
- (d) The team of experts or independent assessment and rating agency shall follow the guidelines for assessment & rating and maintenance of minimum essential standards as may be informed to them from time to time.
- 7. Manner of carrying out Inspections for Assessment and Rating of medical institutions Medical Institutions, shall be inspected for assessment and rating as under:
 - a) The Medical Assessment & Rating Board of Homoeopathy shall authorize such number of inspectors or through authorized third-party independent

rating agency as deemed necessary to inspect medical institutions for assessment & rating and maintenance of minimum essential standards as specified.

- b) Inspections shall be carried out in physical/ online/ hybrid mode;
- c) Institutions shall also be assessed on rating criteria as specified in these regulations.
- d) Rating of medical Institutions shall be made available on the website of the National Commission for Homoeopathy every year.
- e) Inspections teams or Rating agency shall be provided all the required documents duly signed by the authority of the institutions as may be asked to submit during inspection.
- f) The reports with annexures and/or video recording of assessment and rating of a medical institution shall be confidential information and shall be submitted to Medical Assessment or Rating Board for Homoeopathy in a sealed cover or to be submitted online on official mail of the Board.
- g) These confidential reports and related annexures shall be made available on request after final decision has been taken by the authority.
- h) More than one inspection can be conducted during an academic year, if found necessary by Medical Assessment & Rating Board for Homoeopathy or by the Commission.
- 8. **Failure to maintain Minimum Essential standards by existing Medical Institutions** Upon assessment, if an institution is not maintaining the minimum essential standards as specified by Homoeopathy Education Board shall reduce the intake or deny permission for admissions in that particular academic year or subsequent year as the case may be.

9. Imposition of penalty for failure to maintain Minimum Essential Standards of education:

Medical Institutions shall issue warning or may impose penalty for the following reasons by the Medical Assessment & Rating Board for Homoeopathy.

- i) Medical Assessment and Rating Board for Homoeopathy may issue warning to the Medical Institution with the directions to rectify the deficiencies in time bound manner for fulfillment of Minimum Essential Standards.
- ii) Failure to rectify the deficiencies within the time period given, monetary penalty as recommended by Medical Assessment and Rating Board for

- Homoeopathy as approved by the Commission shall be imposed on the Medical Institution.
- iii) Amount of penalty shall be deposited in the Account of National Commission for Homoeopathy.
- iv) Permission to the Medical institution shall be denied in the subsequent year if monetary penalty is not deposited to the Commission in time.
- v) Monetary Penalty shall be imposed on the Medical Institution for submitting forged documents in support of claim for maintenance of minimum essential standards
- vi) Monetary Penalty shall be imposed on the Medical Institution in case of providing false teaching experience to a teacher or to any other staff
- vii) Monetary Penalty shall be imposed on the medical institution having ghost teachers on their faculty list appointed by them as full-time teachers.

10. Inspection for Assessment of new scheme for establishment of new medical institution:

- (a) Inspection for establishing a new medical institution shall be considered after assessment of eligibility requirements as per the norms laid down by Homoeopathy Education Board for imparting undergraduate, post graduate courses on submission of required information and documents along with requisite fee as per the norms.
- (b) New institution shall be assessed keeping in view of the following requirements before issuing Letter of Intent:
 - i. Adequacy of infrastructure and financial resources as per norms and Minimum essential standards laid down by Homoeopathy Education Board
 - ii. Written Consent of the required faculty fulfilling the essential qualification and experience, availability of non-teaching staff.
 - iii. Other necessary facilities have been provided to ensure proper functioning of the existing Homoeopathy hospital and as may be required for the medical institution.

- iv. Valid No-Objection Certificate from the State Government after holding inspection of the premises as per the format of the National Commission for Homoeopathy
- v. Valid Consent of Affiliation by the affiliating University issued in the format of the National Commission for Homoeopathy with the report of inspection of the University.
- (c) The application of new scheme shall be returned if the same is not complete in terms of the required documents and facilities mentioned under (b) above.
- (d) <u>Letter of Intent:</u> The Medical Assessment & Rating Board for Homoeopathy shall issue Letter of Intent after verification of required documents and facilities as specified by Homoeopathy Education Board for new scheme through inspection.
- (e) In case of failure to fulfill the requirements for new institution, an opportunity to rectify the defects, within a time period as may be specified by the Board, shall be given.
- (f) In the case of defects not removed, the scheme shall be disapproved by the Board.
- (g) Issue of Letter of permission for new scheme: Letter of Permission (LoP) shall be issued after assessment of compliance of minimum essential standards as per the criteria laid down for infrastructure, teaching and non-teaching faculty, medical and para-medical staff, and other adequate facility required as specified for proper functioning of medical institution including hospital along with the compliance of specific requirements as indicated in the Letter of Intent along with the receipt of the required Performance Bank Guarantee. in favor of National Commission for Homoeopathy. Medical Assessment & Rating Board for Homoeopathy shall verify all facilities after physical inspection of the medical institution, if satisfied on the facilities established in the College and Collegiate Hospital and if convinced, shall issue permission for one academic year. If any essential facilities are found as not addressed, Letter of Permission for subsequent academic year, as the case may be, shall not be issued.

- (h) Letter of Permission shall be issued for the particular academic year for which the application is received.
- (i) New medical institution shall be assessed compulsorily every year for five years from the date and year of opening with required fee.
- (j) Assessment of the new institution shall be carried out according to requirements of phase wise development as per the new scheme requirement specified by Homoeopathy Education Board.

11. Assessment of scheme for opening new Post Graduate Course or higher course of study or training:

(a) Inspection for opening a new Post Graduate Course or higher course or training by a medical institution shall be considered after assessment of eligibility requirements for application as specified by Homoeopathy Education Board through regulation.

Such institution shall be assessed keeping in view of the following before issuing Letter of Intent:

- i. Adequacy of infrastructure and financial resources as per MSR, 2022 for new scheme as specified by Homoeopathy Education Board.
- ii. Adequate academic faculty, non-teaching and supportive staff, additional facilities in Library and Laboratories and all other necessary facilities have been provided to ensure proper functioning of medical institution.
- iii. Adequate hospital facilities and functioning are in existence as assessed through inspection.
- iv. Continuance of Affiliation Certificate with list of faculties and guides issued by the University after the University inspections for the last two years
- v. Approval of faculties for higher Course by the University without affecting Under Graduate Course.
- vi. Valid No Objection Certificate from the State Govt.

- (b) <u>Letter of Intent</u>: The MARBH shall inspect the medical institution and issue Letter of Intent (LoI), if the applicant institution is found eligible. The letter of Intent to start new higher course(s) or training by a medical institution shall include a statement of requirements to be met in respect of buildings, infrastructural facilities, medical and allied equipment, faculty, and other manpower as assessed by the Inspector.
- (c) In case of failure to fulfill the requirements for opening new Post Graduate Course or higher course of study or training, an opportunity to rectify the defects, within a time period as may be specified by the Board, shall be given.
- (d) In the case of defects not removed, the scheme shall be disapproved by the Board.
- (e) <u>Letter of permission</u>: Letter of Permission (LoP) shall be issued after assessment of compliance of the conditions and requirements indicated in the Letter of Intent and on receipt of the required Performance Bank Guarantee/ Security deposit in favour of National Commission for Homoeopathy and appointment of required Faculty, other man power and facilities as per regulations for opening new Post Graduate Course or higher course of study or training. All the facilities shall be verified through physical inspection before approval by the Medical Assessment and Rating Board for Homoeopathy.
- (f) In case of failure to fulfill the requirements as assessed by Medical Assessment and Rating Board, the scheme for opening new Post Graduate Course or higher course of study or training shall be disapproved.

12. Assessment for scheme for increase in seating capacity in the existing medical institution:

(a) Inspection for increase in intake capacity in the existing medical institution shall be considered after assessment of eligibility requirements for application as per minimum essential standards as specified by Homoeopathy Education Board and on submission of required information and documents along with requisite fee.

The existing medical institution applying for increase in seating capacity shall be assessed keeping in view of the following before issuing Letter of Intent:

- i. Adequacy of infrastructure and financial resources as per MSR, 2022 for increase in seating capacity as notified by separate regulations.
- ii. Required academic faculty, non-teaching and supportive staff and other necessary facilities have been provided to ensure proper functioning of medical institution as specified in the scheme.
- iii. Required hospital facilities and functioning are in existence.
- (b) Letter of Intent: The MARBH shall inspect the medical institution and issue Letter of Intent (LoI), if the applicant institution is found eligible.

The letter of Intent to increase in seating capacity in a medical institution shall include a statement of requirements to be met in respect of buildings, infrastructural facilities, medical and allied equipment, faculty, and other manpower.

- (c) In case of failure to fulfill the requirements for increase in seating capacity, an opportunity to rectify the defects, within a time period as may be specified by the Board, shall be given.
- (d) In the case of defects not removed, the scheme shall be disapproved by the Board.
- (e) <u>Letter of permission</u>: Letter of Permission (LoP) shall be issued only after considering the maintenance of minimum essential standards during the last 5 years and also after assessment of compliance and fulfillment of requirements indicated in the Letter of Intent. Submission of required Performance Bank Guarantee/ Security deposit in favour of National Commission for Homoeopathy and appointment of required Faculty and other manpower.
- (f) In case of failure to fulfill the requirements as assessed by Medical Assessment and Rating Board, the scheme for increase in seating capacity shall be disapproved.

13. Rating Criteria for the Medical Institutions:

The Medical Institutions shall be assessed on the following parameters for rating purpose;

- 1. Infrastructure and Equipment
- 2. Human and Financial Resources
- 3. Hospital Operations

- 4. Teaching-Learning Program & Technology
- 5. Evaluation of education program (Course outcome)
- 6. Research & Publications
- 7. Community Outreach Program
- 8. Staff Welfare
- 9. Accreditation like NAAC, NABH, NABL, ISO
- 10. Quality Assurance & Feedback
- 11. Capacity building of the faculty and staff
- a. The components in respect of infrastructure and man power are required to be fulfilled by the medical institutions, as per the specifications of requirement of applicable in Regulations, to have an average score. The higher score shall be given for such institutions who have achieved minimum essential standards as specified by Homoeopathy Education Board and other components like accreditations, research and publications, quality education initiatives and higher educational facility acquired etc.
- b. The detailed scoring shall be made available on the website of National Commission for Homoeopathy.
- c. The medical institutions shall also provide information about rating and various facilities available to them on their website which should compulsorily be available before the admission of next batch.
- d. Assessment & rating shall be done annually.

Based on the scores obtained during the assessment of medical institutions will be graded. Based on the scores, colleges will be rated from A++ Grade, A+ Grade, B+ Grade, B Grade up to C Grade.

A++	Above 80% of the total score
A+	Above 70% up to 80% of the total score

14. Appeals on disapproval of a scheme and denial of permission to existing medical institutions for admissions by the Board:

- a) Where no order is passed by Medical Assessment and Rating Board for Homoeopathy on a scheme within six months of receiving the proposal or on disapproval of the scheme, the person concerned may prefer an appeal to the Commission within 15 days of such disapproval.
- b) Manner of appeal to be considered by the Commission has been elaborated in the 'National Commission for Homoeopathy (General) Regulations, 2022'. An appeal to the Commission shall contain the following information:
- (i) Name and address of the appellant;
- (ii) Name of the President of the Autonomous Board against the decision of whom the appeal is preferred;
- (iii) Particulars of the order including number, if any, against which the appeal is preferred;
- (iv) Brief facts leading to the appeal;
- (v) If the appeal is preferred against deemed refusal, the particulars of the application, including number and date and name of the President of the Autonomous hoard to whom the application was made;
- (vi) Appeal/ prayer or relief sought;
- (vii)Grounds for the appeal / prayer or relief;
- (viii) Verification by the appellant; and
- (ix) Any other information which the Commission may deem necessary for deciding the appeal.
- c) Where the Commission has disapproved the scheme or no order has been passed within fifteen days from the date of preferring appeal under these regulations, the person concerned may prefer a second appeal to Central Government, within 7 days of the communication of such disapproval or, as the case may be, lapse of specified period of fifteen days.

15 Withdrawal of recognition or derecognition of qualification:

- a) Upon inspection or assessment, Medical Assessment and Rating Board of Homoeopathy shall send report to the Commission for withdrawal of recognition or derecognition of qualification granted to the medical institution by a University or medical institution due to the following reasons:
 - i) The courses of study and examination to be undergone in, or the proficiency required from candidates at any examination held by a University or medical institution do not conform to the minimum essential standards specified by Homoeopathy Education Board: or
 - ii) The standards and norms for infrastructure, faculty and quality of education in medical institutions as determined by the Homoeopathy Education Board are not adhered to by any University or medical institution, and such University or medical institution has failed to take necessary corrective action to maintain specified minimum essential standards, the Commission may initiate action in accordance with the provisions of sub-section (2):
 - iii) Commission shall initiate action to impose penalty or take action for suo motu withdrawal of recognition granted to the medical qualification awarded by a University or medical institution.
 - iv) The Commission shall, after making such further inquiry as it deems fit, and after holding consultations with the State Government and the authority of the concerned University of medical institution, comes to the conclusion that the recognition granted to such medical qualification and direct the Homoeopathy Education Board to amend the entries against the University or medical institution concerned in the list maintained by that Board to the effect that the recognition granted to such qualification is withdrawn with effect from the date specified in that order.
 - b) Commission on the recommendation shall write to the Government of the State in which the University or Medical Institution is situated. The State govt shall seek explanation from the affiliating University and upon receiving such explanation shall make the recommendations to the Commission.
 - c) Commission shall further, if found fit may by notification shall withdraw recognition

15. Criteria for relaxation:

The Commission upon consultation with Central Government shall relax Minimum Essential Standards as specified by Homoeopathy Education Board for medical institutions which are set up in such areas like Hills, Tribal, North-Eastern States, or as deemed necessary by the commission in consultation with the central government subject to the condition that quality of-education and health care services shall not be affected seriously.
