With reference to the subject cited above and referred letter and with the approval of Competent Authority, I am directed to inform all Counselling Authorities that, it is decided to lower the cut-off percentile by 5 percentile across all categories for admission to UG and PG courses under Ayurveda, Siddha, Unani & Homoeopathy streams of NEET UG 2023 and AIAPGET 2023 for admission to ASU&H – UG and PG Courses for the Academic Year 2023-24 as follows:

Further, in order to implement the percentile reduction and subsequent Counselling processes, it has been decided to extend the cut-off date for admission to ASU&H – UG Courses from 20th November, 2023 to 30th November, 2023. Counselling Authorities are also advised to allow fresh registrations for remaining rounds of counselling. However, the cut-off date for Post Graduate admissions remains same i.e. 16th December, 2023. The data of eligible candidates category wise after reduction of 5 percentile will be shared shortly.


