

Subject: Participation of AYUSH institutions in AISHE

Madam.

As you may be aware, D/o Higher Education has been conducting All India Survey on Higher Education (AISHE) since 2010-11 covering all the institutions imparting higher education in the country.

So far 10 such surveys were completed by the Department the last being AISHE 2019-20.

The registration of new institutions for AISHE 2020-21 is presently undergoing.

The survey covers three types of institutions such as Universities (including Institutions of National Importance), Colleges and Stand Alone Institutions (which are affiliated to different statutory bodies and running diploma and certificate courses on specific fields).

The survey collects very useful information like programme-wise enrolment, details of teaching and non-teaching staff, infrastructure available with the institutions, examination results, etc.

All the details of the survey along with previous survey reports and data are available at http://aishe.gov.in

is understood that AYUSH Ministry maintains the complete list of institutions (both public and private) that impart courses on Ayurveda, Yoga and Naturopathy, Unani, Siddha and Homoeopathy.

Such a list was obtained by our division from AYUSH ministry to check whether all these institutions are registered with AISHE. Even though we could match a number of those institutions with the institutions registered with AISHE, the exercise could not be completed as there are differences in names, use of abbreviations, etc.

A list of universities, colleges and stand alone institutions that are spec aliased in AYUSH (as per AISHE 2019-20) has been extracted from AISHE database (based on specialization/ name of the institute) is attached herewith for your ready reference.

However, there might be other AYUSH institutions not included in this list which are already registered with AISHE.

It will be helpful, if you also include the AISHE code in the database of institutions maintained by AYUSH ministry.

This will help you to generate customized reports based on the AISHE data specific to AYUSH institutions, which will be of great use for sector specific policy formulation and evaluation in higher education in AYUSH.

I therefore, request you to provide us with the list of AUSH higher education institutions along with their AISHE codes.

In case if there are AYUSH higher education institutions that are yet to be registered with AISHE, you may please request them to complete the AISHE registration at the earliest so that they will be in a position to participate in the AISHE 2020-21.
