

The candidates who are studying in the M.D.(Homoeopathy) Part II/ Final year & have either completed the period of study of 36 months or have their M.D. (Homoeopathy)/part II exam scheduled on or before 31.05.2026 may apply for the NTET 2026 examination. Such candidates are required to submit the **NO OBJECTION CERTIFICATE (NOC)** from their respective institution/college as per format attached at **Annexure-I**.
