Madam/Sir,

In response to the Notification issued on 10.10.2023 and the regulation mentioned in the subject above, this office received multiple representations from colleges as well as students informing that majority of colleges in the States conducting courses in Homoeopathy have not yet been included in Medical Qualification Recognition List and hundreds of students who have qualified BHMS from such colleges will not be able to seek admission to PG courses in Homoeopathy as their registration with State Councils/ registration boards has been stalled since institutions from which they have completed their BHMS degree is not being included in Medical Qualification Recognition List.

Further, as a part of Admission process for allotment of admissions to PG courses in Homoeopathy, it is mandatory for candidates seeking admissions to PG courses in Homoeopathy, to furnish provisional/permanent registration till 1st December 2023 informed vide letter no. 3-97/2023/NCH/HEB-AA-CCC/ 5501 dated 22.09.2023(copy enclosed).

Sub: Recognition of UG/PG medical qualification of Homoeopathy awarded by concerned University and inclusion of the same in the Medical Qualification Recognition List (MQRL) (Section 35 of the NCH Act, 2020) maintained by the Homoeopathy Education Board of National Commission for Homoeopathy-reg.

Madam/Sir,

With reference to the subject cited above, it is to inform that regulation namely "National Commission for Homoeopathy (Recognition of Qualifications of Homoeopathy) Regulations 2023" is published online in e-Gazette of India on dated 19.07.2023.

Sub-regulation (4) of regulation 3 of "National Commission for Homoeopathy (Recognition of Qualifications of Homoeopathy) Regulations, 2023" states as below: -

"All the Universities or medical institutions after the notification of this regulation shall apply for further continuation of recognition of the qualification in the medical qualification recognition list in the prescribed Form A or Form B as the case may be, in the manner and procedure as mentioned regulation 4."

Sub-clause (a) of sub-regulation (2) of regulation 4 "National Commission for Homoeopathy (Recognition of Qualifications of Homoeopathy) Regulations, 2023" states as below: -

"(a) University or medical institution fulfilling the eligibility criteria as specified in sub-regulation (1), shall submit duly filled application form offline or online addressed to the President, Board,- (i) for undergraduate Course or any other medical qualification in Homoeopathy as recommended by the Board, application shall be submitted as per the given format specified under Form-A within forty-five days of completions of undergraduate internship.

(ii) for postgraduate Course application shall be submitted as per the given format specified under Form-B within forty-five days of completions of postgraduate Course.

Continued.....



Provided that newly established institution of undergraduate Course with due approval by Medical Assessment and Rating Board for Homoeopathy or the Central Government, may initiate the process for applying for grant of recognition of qualification through the degree awarding University, when the students enter internship:

Provided further, that if the established medical institution started a new Course or Higher Course in Homoeopathy with due approval by Medical Assessment and Rating Board for Homoeopathy, may initiate the process for applying for grant of recognition of qualification through the degree awarding University, when the students are in final year of the respective course."

For recognition of qualification in medical qualification recognition list (MQRI.), following points to be kept in notice while sending the details/data of the students:

- Details/data should be prepared and sent for B.I.H.M.S students who completed their internship after 19.07.2023 as per Form A (for UG).
- Details/data should be prepared and sent for M.D. (Hom) students who completed their course after 19.07.2023 Form B (for PG).
- All the documents to be submitted through proper channel (through University only), separate copies of documents need not be sent by the college to Homoeopathy Education Board, National Commission for Homoeopathy.
- Signature of Registrar of university with seal and date is mandatory.
- Documents should be as per the enclosed format. (Form A/ Form B)
- Details of the student should be batch-wise and clear information may be sent.
- Details of atleast 50% of the students of particular batch who completed their internship or M.D. (Hom) course must be sent for recognition of qualification of Homoeopathy.

Kind Attention: All candidates/institutes participating in PG-Counseling, 2023 are informed in respect of submission of following mandatory documents at the time of reporting at the allotted institute.

i. **Twelve months Compulsory Rotatory Internship Completion Certificate:**

Candidates who have not completed their **Twelve months Compulsory Rotatory Internship** at the time of admission/reporting for Round-1 and Round-2 of PG counseling are instructed to submit an Undertaking (**Annexure-1**) counter-signed by the Head of the Institution (the institution from where internship is being pursued). Further, such candidates must submit their original Compulsory Rotatory Internship Completion Certificate at the allotted institute **on or before** the last date for reporting to the allotted institutes specified by the respective counseling authority for 2nd round of PG counseling. Otherwise, his/her admission shall stand cancelled. The vacant seats thus arising shall be added to 3rd round counseling.

ii. **BAMS/BUMS/BHMS/BSMSCertificate/DegreeCertificate/ProvisionalDegree Certificate.**

If a candidate not able to produce a valid Provisional Degree Certificate due to non-completion of Internship at the time of admission/reporting for Round-1 and Round-2 of PG counseling, in that case, the candidate shall submit an undertaking stating that **he/she will submit the valid Provisional Degree Certificate at the allotted institute on or before the commencement date of PG course (i.e. 01st December, 2023) for the academic session 2023-24 as already informed by NCISM/NCH.**

iii. **Permanent Registration Certificate issued by NCISM/ NCH/ CCIM/ CCH /State Ayurveda/Siddha/Unani/HomoeopathyBoard:**

Candidates who have not completed their **Twelve months Compulsory Rotatory Internship** at the time of admission/ reporting for Round-1 and Round-2 of PG counseling, are instructed to submit a copy of the **Provisional Registration Certificate** at the time of reporting. Further, such candidates shall submit their original Permanent Registration Certificate **at the allotted institute on or before the commencement date of PG course (i.e 01st December, 2023) for the academic session 2023-24 as already informed by NCISM/NCH.**
